
This is the abridged version of the book that was posted online. Feel free to use this version of the text as a way to scaffold up to the grade-level text.


Additional TKAM Unit

EXTENSION ACTIVITIES

Character Cube



<u>This worksheet</u> is intended to help students identify characters in the story. With this activity, students select a character to do an in-depth analysis of the character's traits while completing a hands-on activity. For this activity, you will need a writing utensil, scissors, crayons or markers, and glue or tape. <u>This cube with instructions</u> will guide the student through the steps needed to complete the activity.

Length of Activity: 30 minutes

For Use: After all of the main characters have been introduced. It can be used at around the halfway point of the book, or at the end so that students have a good idea of all characters.

Trial Notes



This worksheet is intended to help keep track of information and witnesses during Tom Robinson's trial. Use it as a way for students to remember which witness gave what specific information and testimony to help students draw conclusions based on the facts.

Length of Activity: 30-45 minutes

For Use: This can be used once the trial has begun in Chapter 17.

Then and Now



This is a graphic organizer to help students as they read and track various characters in the story. Students can use them for only the main two characters, or they can use them for the majority of the characters that are introduced into the story.

Length of Activity: 15 minutes

For Use: This can be used throughout the book.

Texting With a Character



This worksheet is intended as a way for students to bring the characters in the story to life using materials and methods that are relevant to students in today's world.

Length of Activity: 20 minutes

For Use: Any time after several characters have been introduced.

Stepping in Someone Else's Shoes




This is a worksheet that was created to help students understand another person's perspective by "stepping into their shoes".










To Kill A Mockingbird

Chapters 1 – 3



The story is set in a small town in Alabama named Maycomb. Jem and Scout lived there with their father, Atticus. Jem and Scout's mother died when Scout was very young. She doesn't remember her mother, but Jem does. Calpurnia, the family's cook, also lives in the house.

The story starts out when Jem was ten and Scout was six. One day, they meet a boy named Dill who is visiting for the summer. Dill was seven years old. Jem and Scout were happy to have someone to play with.

Every day, the three children played together. Sometimes they played in the treehouse. They liked to put on plays. There was another house near their home called "The Radley Place." It was very mysterious because they never saw the people who lived there.

Dill dared Jem to walk up and touch the house. Jem was scared, but he did it anyway. He ran up and touched the house, then they all three ran home fast. When they turned around and watched, they believed they noticed the curtains move.

At the end of the summer, Dill went back home, and Scout started school for the first time. Scout was excited because she used to watch all the school kids play, and now, she was going to be able to play with them too.

Scout's teacher, Miss Caroline, was new to the school and did not know the students well. Miss Caroline called Scout Jean Louise. Miss Caroline asked Scout to read for the class but got upset with Scout because Scout knew how to read so well.

At lunchtime, Miss Caroline tried to give money to a little boy named Walter. Walter's family was very poor, but he wouldn't take the money. Scout tried to explain to Miss Caroline why Walter wouldn't take the money, but Miss Caroline thought Scout was trying to be funny. She patted Scout on the hands with a ruler and made Scout stand in the corner.

Scout was having a bad day.

Scout started picking on Walter because of what happened in class, but Jem made her stop. Scout and Jem walk home for lunch every day, and Jem invited Walter to come and eat lunch with them.

When Walter asked for syrup and poured it all over his food, Scout teased him. Calpurnia made Scout sit in the kitchen for the rest of lunch. Calpurnia said it was important to be nice to visitors. After lunch, Scout told Atticus that he needed to fire Calpurnia, but Atticus said that Cal was an important part of the family. Back at school, Miss Caroline screamed at Burris Ewell when she saw bugs in his hair. The Ewell kids only came to school on the first day each year, and Burris started being mean to Miss Caroline and made her cry.

That evening, Atticus asked Scout if she was ready to read with him. Scout said her teacher told her to stop reading at home because Atticus was teaching her wrong. Atticus tells Scout that she needs to try to understand other people better, and to do that, she needed to look at things from their point of view. Scout didn't want to go back to school, but Atticus made a deal with her. He said if she goes back to school, he will read with her every night. It would be their secret. Scout agreed and was happy.



To Kill A Mockingbird

Chapters 4 - 6



Coming home from school one day, Scout saw two shiny gum wrappers in a hole in a tree in the Radley's front yard. Scout tasted one to make sure it wasn't poison, then she chewed them. When Jem found out where she got them, he made her spit the gum out. Jem was afraid they were poisoned.

Going home after the last day of school, Jem and Scout found something else in the tree. It was a little box with two special pennies in it.

Dill came back for the summer again. Jem, Scout, and Dill got bored were playing with a tire. Scout got in the tire, and the boys rolled her down the street. She hit something and came to a stop in front of the Radley's house. Jem got upset and ran to help her.

After that, they made up a new pretend game they called The Radley's. Scout pretended that she was Mrs. Radley, Dill pretended he was old Mr. Radley, and Jem pretended he was Boo Radley and hid under the steps.

<u>Every day they played "The Radleys."</u>

One day Atticus saw them and asked if they were playing "The Radleys." Jem lied and said, "no." Scout wanted to stop playing because Atticus had seen them, and because when she fell in the tire, she had heard someone in the Radley's house laughing.

Jem suggested they keep playing the game but change the names of the Radleys so no one would know.

Jem and Dill started spending more time together without Scout, so Scout decided to spend her time with their neighbor Miss Maudie. Scout asked Miss Maudie if Boo Radley was still alive. Miss Maudie said yes, she knew because she hadn't seen anyone take a body out. Scout said they could have stuffed the body up the chimney. Miss Maudie knew Boo when he was a boy, and she told Scout that he had been a very nice boy.

One morning, Scout found out that Jem and Dill were planning to get a note to Boo Radley. The note asked Boo to come outside and have ice cream with them. Jem hooked the note to the line of a fishing pole and tried to push the note through one of the Radley's windows. Dill was watching to make sure they didn't get caught--but Atticus caught them anyway.

Atticus tricked Jem into admitting that they were still playing the game about the Radleys. Atticus told them to leave Boo Radley alone because Boo had the right to stay in his house if he wanted to. He tried to get the children to see that they shouldn't judge Boo without trying to see things from his perspective.

On Dill's last night in Maycomb, he and Jem decide to peek into the Radley's window and try to see Boo. Scout decided she was going with them.

When they started to go to the backyard, the gate squeaked, and they spit on it to make it stop. They had to crawl under barbed wire and through a garden.

Dill looked in one of the windows but couldn't see anything. Jem looked in another. He didn't see anything either. Then Scout saw a shadow of a man with a hat. The three children ran, and when Scout tripped in the garden, they heard the roar of a shotgun! Jem's pants got stuck on the barbed wire when they crawled back under the fence. He got out of them, and they ran home.

All the neighbors were outside because they had heard the gunshot. Mr. Radley said he had shot at a black man who was in his backyard.

Atticus saw Jem without his pants and asked where they were. Dill said Jem had lost them while playing a game. That night, Jem sneaked out of the house to get his pants. Scout was afraid for Jem to go by himself, but he went anyway.



The fire trucks could not save her house so they started watering the roofs of other houses so they would not catch on fire. The neighbors stood and watched the fire burn unitl morning. When Jem and Scout got back into the house, Atticus asked Scout where she got the blanket she had around her. Scout did not remember, but Atticus said he thought it was Boo Radley who put the blanket on her. Jem told Atticus about the gifts in the tree.

Scout heard Cecil Jacobs, another student at school, say that Scout Finch's daddy defended black people. He was teasing Scout about it. When she asked Atticus, he said he was defending a black man by the name of Tom Robinson. Atticus said he had to defend Tom so he could hold his head up in town and not be a coward.

At Christmas, Scout and Jem's Uncle Jack came to visit. He gave the kids air rifles. Then they all went to their Aunt and Uncle's for Christmas day. Jem and Scout visited with their cousin, Francis. Francis began to tease Scout about her dad Atticus being a "Nigger-lover" because he was defending Tom Robinson. Scout got very upset and hit Francis. Scout got into trouble with Uncle Jack because he thought it was Scout's fault. Later that night, Scout told Uncle Jack he was not fair. Scout said her dad always listens to both sides of a story before deciding who was wrong. Scout never had a chance to explain to Uncle Jack about the teasing that Francis was doing. Uncle Jack felt bad that he was so hard on Scout when he heard the whole story.



Atticus was almost 50, and Scout and Jem thought that was very old. Jem complained that Atticus never did anything like play touch football with him, or at least go hunting or fishing.

Atticus wouldn't teach the kids to use their air guns, so Uncle Jack did. Atticus didn't want them to shoot birds. He told them that if they did, not to shoot a mockingbird because it was a sin. Miss Maudie explained to Scout that it was a sin to kill a mockingbird because all they did was make music for people to enjoy.

One day Scout and Jem saw a dog that had Rabies. Atticus and the sheriff, Mr. Tate, came quick. Mr. Tate told Atticus to shoot the dog to put it out of its misery. Atticus didn't want to. He had not shot a gun in 30 years. But he used Mr. Tate's gun and shot the dog. He killed it in one shot. Miss Maudie said people used to call Atticus "one-shot" because he could shoot so well when he was young.

Scout told Jem they would have something to brag about the next day in school. But Jem told her to keep quiet about it. Jem realized that his father was a gentleman and that gentlemen never bragged about their talents.

On Jem's 12th birthday, he he wanted to use his birthday money to buy a toy train and a baton for Scout. When they walked past Mrs. Dubose's house, Mrs. Dubose yelled at the children that their father was a "nigger-lover." Jem got mad, and on the way back home, he used Scout's new baton and to destroy all Mrs. Dubose's flowers. Jem's punishment was to read to Mrs. Dubose every day for a month.

Scout went with Jem to read. Every day, an alarm would go off, and Mrs. Dubose's helper would come in to give her medicine and tell the kids to go home. The alarm went off later and later each day.

One night after Jem was finished with his punishment, Atticus came home and told them that Mrs. Dubose died. He explained that Mrs. Dubose had been in pain, and because of it, had become addicted to morphine. But Mrs. Dubose had wanted to stop being addicted. So she used Jem's reading to keep her distracted from the pain, and every day she was able to put off taking her medicine a little longer until she broke her addiction.

Atticus said that she was the bravest person he knew. He said that real courage came when you knew you were licked before you started, but you started anyway, and you see it through no matter what.

Now that Jem was 12, he started changing and telling Scout to start acting like a girl. He didn't want to spend as much time with Scout, so she spent her time with Cal. Cal said Jem was growing up and even started calling him Mr. Jem like he was an adult.

That Summer, Dill didn't visit because his mom got married. He had to stay at home. Atticus went away for two weeks, so on Sunday, Cal took the kids to her church. 



The next morning they all ate breakfast and talked about what happened the night before. Atticus said that the mob was just a bunch of men and that it took an eight-year-old to remind them of that. Aunt Alexandra said children who snuck out at night shamed their families.

Atticus left for the courthouse. The children sat on the porch and watched people walk by the house going downtown to watch Tom Robinson's trial. After lunch, Jem, Scout, and Dill went downtown too. Everyone was sitting outside the courthouse having picnics. When it was time for the trial, there were so many people that Jem, Scout, and Dill could not find a place to sit. Reverend Sykes from Calpurnia's church took them up to the balcony. Just as they were sitting down, the first witness took the stand. The witness was Mr. Tate, the sheriff.





Dill and Jem had begged for a ride, and Atticus said yes but only if they stayed in the car. Atticus and Calpurnia were on their way to tell Mrs. Robinson that her husband had been shot and killed.

Children were playing in the yard when they got to the Robinson's cabin. Atticus asked a boy where his mother was. The boy said he would get her. When Atticus told Mrs. Robinson the news, she fell to the ground. Calpurnia and Atticus carried her into the cabin.

Mr. Underwood wrote an article in the newspaper. He was upset about Tom being killed. He said that it was a sin to kill cripples, even if they were escaping. He compared it to the senseless slaughter of songbirds by hunters and children.

Mr. Ewell said about Tom: "It made one down and about two more to go". Jem told Scout not to be afraid, that Mr. Ewell was full of hot gas.

Third, Helen Robinson, Tom's widow, got a job. She had to walk by the Ewell house to get to her job, and when she did, Bob Ewell would yess and say mean things to her. When Helen's boss found out about it, he told Bob Ewell to leave her alone or he would call the police.

It was almost Halloween, and Scout was to be in a play about Maycomb County. Scout was happy because Jem said he would take her to the play.
